MEADOW PROJECT

County will pay for 1-acre development ½ acre between parking lot and diner, and another section at Village on the Green. The project is moving forward, with local funding in the works. Joanne met with Village on the Green Association president, Russ Staniec, to get the association's input for the site.

ENERGY

Garden supplies are in place, but it hasn't been put in yet. The Green Team was reminded to VOTE for the school referendum on **October 2** and to review their polling place. There are many green improvements that will be applied from this referendum. There will be a table at Community Fest promoting the garden and newspaper pots with native seeds to give out. Garden is mostly vegetables for culinary club. Pollinator gardens may be put into the old beds. Recycling issues are still not resolved. Recycle bins are used in the school, but not sorted out when trash is taken out. HS environmental club may help with scarecrow contest.

TRENTON WATER WORKS MEETING

Ewing hosted the meeting. Can this be applied to Sustainable Jersey? Issues about water quality, how to assess if you need the connecting pipe from your curb to the city waterline, that will be replaced by the city, with possible loans to homeowners. The issue of lead solder is tabled for now, and focus is just on pipe. Lead Poisoning- each people can replace their lead pipes, but is there anything upstream that would contaminate- nothing is guaranteed. Water purification and filtering systems will be reviewed and placed on their website for systems that can remove lead- most filters like Brita, Purr etc. aren't made to remove lead. NJ Safe Water Act

GM construction has begun. Naval Facility has no interest, although some improvements have been made regarding water, but there are complications for when they are razed (contaminations)

ENVIRONMENTAL COMMISSION

The EC is working on a tree ordinance to protect the local tree canopy. The EC will function as a shade tree commission which is required to become a Tree City, USA. The tree ordinance will exempt residential properties and focus on public and commercial lands, unlike many other townships in the area. It is our first attempt at codifying a policy to protect our tree canopy which we are losing to rapid development. We will see how it works and amend as needs change in Ewing.

Standardizing grass cutting ordinances- inconsistency over how many inches for grass allowance. It is now 6 inches, and you have 3 days to comply. There is certification available from Department of Health for natural habitat (although no one has utilized it). Movement was made for medical marijuana in Ewing, 6 permits will be issued soon. Idea was suggested that citizens take an active role in clearing their storm drains, as townships often cannot keep up with the demand. Also, leaves cannot be on the street, (use public easement strip) and there is limited time that you can have it there too.
