The meeting was called to order at 7:05 by Chair Joanne Mullowney. The August and September Meeting Minutes were approved by the members. Joanne then introduced the featured speaker of the evening, Maya Van Rossum, who has been the Delaware Riverkeeper since 1994. The role of the Delaware Riverkeeper is to help keep the Delaware River and the surroundings well maintained for the people and communities who depend on it for a clean, safe water source. They must ensure that 'no harm' is done to this important resource. The Delaware Riverkeeper advocates for strong and vital river stewardship.

Ms. Van Rossum has also been a strong proponent for the passage of a Green Amendment in New Jersey. She can be seen in the PBS production 'Here's the Story – 'One of Waters.' The aim of the Green Amendment is to protect the rights of every New Jerseyan to a clean and healthy environment. Federal and state legislation to protect natural resources have been insufficient and New Jersey water, air, forests, and other special places from the highlands to the pinelands have been allowed to degrade in ways that are harming people's lives.

The amendment will update the state constitution to recognize that "Every person has a right to a clean and healthy environment....", that the State has a duty to serve as trustee of the state's natural resources, and must conserve and maintain them for the benefit of all people. The need for the Green Amendment has been growing in part due to the realization that current system of laws are not working adequately to protect the environment. This is a newer concept.

As an example, laws that focus on how to address ongoing pollution basically permit it to happen and deal mostly with results and attempt to find ways to deal with its many effects instead of trying to find ways to prevent pollution and degradation in the first place.

The Green Amendment aims to remedy:

- PFAS or PFOS – no amount is safe.
- It also recognizes that environmental racism is built in; sadly, targeted are communities of color and low income.

- Communities are drinking contaminated water; and species being lost.

## HISTORY

In 1969 Pennsylvania Senator, Franklin Kury wrote Article 1, Section 27 of the Pennsylvania Constitution, popularly known as the 'Environmental Rights Amendment.' This was also known as the 'Bill of Rights – a recognition and duty to protect the natural environment.' The first time this was used was in 2012-13 to help fight the pro-fracking policies. Fracking was doing incredible harm to the environment and causing devastating impacts on communities. Fracking Industry legislation allows for waivers for minimum standards which would allow things to get worse.

The Delaware River network was successful in keeping fracking away from the Delaware watershed. It would violate the environmental rights of all people who depend on the Delaware River for healthy environment, water, and air.

New thinking is to restructure decision-making approach rather than dealing with the effects of pollution think about making decisions how to prevent degradation in the first place – rethinking how it affects a healthy environment.

## HOW AND WHEN DID THIS ALL START IN THE GREAT STATE OF NEW JERSEY?

On November 30, 2017, New Jersey Assemblyman Tim Eustace, joined by Maya van Rossum, the Delaware Riverkeeper, Assemblywoman Pinkin and Assemblywoman Sumpter, announced new legislation that, if passed, would amend Article 1 of the state constitution to recognize that "Every person has a right to a clean and healthy environment....", that the State has a duty to serve as trustee of the state's natural resources, and must conserve and maintain them for the benefit of all people. Since its original proposal there has been significant forward progress. We need enforceable legal laws.

It would be helpful if municipalities and cities would show support for the Green Amendment with passage of local resolutions. This would send a message to legislators that the people of the State do support it. Only about a half-dozen towns currently have resolutions.

Participants need to register for the 3-part leadership training to help secure a right to a healthy environment.

Over half of the NJ General Assembly and 12 Senators have indicated support. There are two bills proposed with parallel language, if passed by the legislature, the amendment would go to public ballot.

Marisa Benson commented that the Dodge Foundation has initiated partnerships with indigenous peoples.
