We are looking for new continuing education points. The Township is required to earn new CEUs for New Jersey's Urban and Community Forest Management Program's accreditation requirements every year. Ewing currently has 29 CEU's and the requirement is 8 points, so we're okay. We need to send in annual report for 2024 shortly to be accredited for the work we have done this year.

The Tree Ordinance also needs to be updated to meet the last stormwater regs.

STORMWATER

Storm Water requirements must be updated to meet new requirements.

FALL LEAF PICKUP

The new leaf collection is going back to residents raking all the leaves to the curb for pick up with the new Ewing truck that picks up the leaves at the curb. The township is trying to manage it with a very tight collection schedule and plenty of advertising to help residents to realize where and when they can put out their leaves to better keep the storm drains clear.

SUPPORT LOCAL BUSINESSES

PLASTIC BAGS

An article came out about the results of banning plastic bags. Apparently, people are still forgetting to bring in their reusable bags, so they end up buying the cheap bags offered by the grocery store. It would be helpful if we had signs out in the parking lot reminding shoppers to bring in their bags.

'Skip the Stuff' is a program for restaurants, or any take-home meal service to no longer include the plastic silverware, straw, or any other plastic items in with the meal. People would have to request these items; they would no longer be included.

ROAD SALT VIDEO FROM ANJEC

We showed snippets from the ANJEC webinar to give meeting participants highlights of the content.

- Road salt testing program is measuring salt levels in our waterways before and after a weather event, i.e. snow or rain. We've participated in this for the last 3 years. the Watershed runs this throughout the state. This helps to follow the amount of salt being washed into our local water.
- ANJEC storm water impact – helps to educate students, environmental groups.
- Road salt is effective on our roads down to 20 degrees. More exposure to water lowers the temperatures and lower freezing point on a road.
- Too much salt in our waterways means no longer fresh water, nutrients are leached out. This affects the normal cycle. Salt does not go away. This could be dangerous. Salt does not go away, it is corrosive.
- Helpful for volunteers to help baseline reading for salt in water. Below 50 º is okay. 650 is extremely high. It stays elevated even after months.

The EGT is looking for people to do the measurements. Kathy B. will do Jacobs Creek, that's helpful since we're never done that before. If you want to help, let Joanne know. She will register us in their program. She will also get the test strips/kit. Devin will do Shabakunk/Temple Park. Shabakunk Hills off Lopatcong- Bob Kirby. Ruth Chin will do the canal by Wilburtha Road.

The meeting adjourned at 8:43.
