Some of the webinars that we have been encouraged to attend offer CEUs (continuing education units) that we can use for credit towards our annual NJ Urban and Community Forestry certification. We have 4 GT members who are attending the NJ Native Plant Society event on March 1st. This will give us 12 CEUs.

SUB COMMITTEES

SUSTAINABLE JERSEY

SJ Overview and Ewing participation. Ewing submitted its fifth SJ submission this past weekend. In the past we had the following record:

- 2013: Bronze Certification, 14 actions for 185 points across 8 categories
- 2016: Silver Certification, 36 actions for 460 points across 14 categories
- 2016: Sustainability Champion Award for Medium Size (5,000 - 39,999) Municipalities.
(The award is for receiving the highest number of points in this population category)
- 2019: Silver Certification, 45 actions for 510 points across 16 categories
- 2022: Silver Certification, 43 actions for 465 points across 16 categories

TREES

The Ewing Township Tree Ordinance is in the process of being updated as part of the requirements for the Stormwater Management Plan. Update from Dave.

The update to our Tree Ordinance was voted and adopted by Township Council on January 28th.. Our ordinance is now in better compliance with DEP's requirements. This also helps with new stormwater regulations. Changes included the wording on oversight of County and State properties. We do not have the regulatory authority to enforce Township ordinances on those properties.

- Joanne worked on the Annual Report with Ryan for the NJ Urban and Community Forestry Management Program recertification.
Ewing had 33 CEUs for the required continuing education credits out of the needed 8. We were in good shape for our submission and were certified.

We had well over the required \$2.00 per capita. In total, our accomplishments would merit us a Tree City USA designation. We plan on applying next year.

- Annual Arbor Day celebration

Arbor Day is April 25th (we celebrate on Saturday 26th). Every year since 2018 the EGT has donated a tree, along with Environmental Commission.

Originally, we donated trees at Benjamin Temple House, along the driveway. The last couple of years we donated nice sized trees at Watson Park. They were about \$300+ and \$200 for the planting. Dan Burke, local landscaper has his people dig and plant the tree. People usually donate \$20. Any suggestions for this year's location?

Large grants are being applied for updating Limato Field and soccer fields behind the Municipal Building. Maybe donate a tree for one of these locations? Maybe plant smaller trees, which is less expensive, we could create a small grove (3 trees?). The smaller trees have less transplant shock. We need to think about deer pressure, so perhaps Public Works could help with protective fencing around new trees. Joanne will speak to Ryan Rollero, Public Works Director, to see if they would be able to help with fencing.

Friends of Hopewell Valley Open Space (FOHVOS) has an annual sale (1/2 off) on native plants, and it just started today (Feb 26). The sale is for 10 days. They might be a good source for us to buy 3 of 4 small 2 gallon or 7-gallon size trees.

STORMWATER/WATER ISSUES

- NJ Salt Watch – members are continuing to report in.
Kathi B. did Jacob's Creek (bottom of Bear Tavern Road). On December 15 there was almost no salt, 49 ppm. However, her most recent check was 114 ppm. We will do one last test. Everyone needs to get additional test strips. These are no longer free -The Watershed now asks for a donation. (Joanne gave \$80 to cover the cost of our project)
